- On October 1, 2018, Honeywell International Inc. ("Honeywell") disposed of all 74,070,852 shares of Garrett Motion Inc., a Delaware corporation ("Garrett"), common stock, par value \$0.001 per share (the "Garrett Common Stock"), issued and outstanding by distributing a pro rata dividend to Honeywell's stockholders one share of Garrett Common Stock for every ten shares of Honeywell common stock, par value \$1.00 per share held by each holder of record as of 5:00 p.m. New York City time on September 18, 2018, to effect the legal and structural separation of Garrett from Honeywell.
- Because an employee of Honeywell was a director of Garrett, Honeywell was previously deemed to be a director by deputization.
